Gujarat High Court has launched software called Prisoner Information Module (PIM) for the welfare of prisoners and their families across the state. The software has been created in a bid to extend legal help to prisoners and their families through Gujarat State Legal Services Authority (GSLSA) which is providing free legal help to the needy. Sources at Gujarat HC said, the module is integrated with District Judicial Data Grid (DIDG) of High Court of Gujarat, from which it automatically fetches the details of under trial prisoners (UTP) and convicted prisoners. It also allows the jails to update all the details of the prisoner, his release on bail, parole and furlough during his jail term including all details of his family members and children.

The DJDG is the portal that keeps data of the all types of the legal cases. Due to the PIM, it will be easy to keep, access and furnish all the data of concerned prisoners by the jail authority and produce it before the court or hand over to the police as and when required. At present it is

being done manually and take substantial time and energy to retrieve it from the books. Explaining the reason behind the PIM, the top official said, "In many cases either prisoner or his family members are not aware or informed about the status and outcome of the cases. In that case, the date filled in the PIM will help to give information to the kin of the prisoner. It will also give benefit of free legal help and other beneficial schemes through para-legal volunteers in them." the jail to

According to official sources, the details of the family members of the jail inmate will be updated in the PIM along with the email address or the mobile number of the family members from time to time. It will be implemented in jails across the state and they have access of the PIM to enable data feeding and look at welfare schemes for prisoners.
